NEW LOCATION! FAIRFAX HIGH SCHOOL, 59TH AVENUE SOUTH OF BASELINE

The 60th Annual Laveen Pit Barbecue is scheduled for Sunday, February 12, 2012. We are moving this year due to the demolition of the old Laveen Elementary School. We are now taking applications for participants in the vendor/exhibitor portion of our event. If you are interested, please fill out the application and return it along with your **space fees and a self-addressed, stamped envelope. Sign your application. Unsigned applications will be rejected.**

Please list special requests on your application regarding your space. (i.e.:prefer corner, direction to face, etc) We will assign spaces in the order applications are received. Corner spaces and spaces facing the eating area will be considered premium spaces with a \$35/space additional fee or will be reserved for sponsors. **New this year: There are 20 spaces on concrete around the eating area, 9 of which are under cover. These spaces are considered premium at the \$35 additional charge. (Note your interest under special requests and include a separate \$35 check)**

Applications will be accepted in one of the four categories listed below:

- 1) Exhibitors of Equipment, Vehicles, Animals or Wildlife. **NO CHARGE**
- 2) Community Groups, Non-profits, Public Schools, Churches \$40 or **NO CHARGE for member groups of the LCC**
- 3) Artists & Craft Vendors—products **must be** created by applicant-- \$50 (\$10 for youth under age 16)
- 4) Commercial, Product re-sellers (items not created by applicant) or business promotion \$100
*****NOTE: This category is limited to Laveen residents and businesses from Laveen or South Phoenix ONLY.**

Vendors are encouraged to purchase their BBQ meal tickets along with their space rental to save time at check in. Pre-sold tickets will have priority for quicker food service. Tickets purchased in advance are \$7 and \$5 but on the day of the BBQ tickets will be \$9 and \$6.

We are looking forward to another successful event and hope you'll plan to join us!

RULES AND REGULATIONS:

Receipt of your booth fee is your reservation. The spaces will be assigned in the order applications are received. No verbal reservations will be taken. **We always fill up, so don't delay! After January 20, the fee increases to \$60 for artists and \$125 for commercial. All applications must be received by February 6, 2012.** No refunds will be made after January 31, 2012. The event goes on come rain or shine so plan appropriately.

You are responsible for all your fixtures. The only thing we provide is the space. No electricity is available for any space. Spaces are on grass and concrete. If you have a canopy, you must anchor or weight it down in case of wind. (no stakes allowed due to sprinkler lines)

Products displayed, sold or given away in the vendor areas must not compete with the Barbecue itself or any of the products provided by other community groups. You may not sell or **GIVE AWAY** any products not listed on your application. Please be **specific and complete** in listing your proposed sales or promotional items. Your check will not be cashed unless your application is accepted. You will be sent set-up instructions and confirmation of your space number **if you sent the required self-addressed, stamped envelope with your application.**

You will need to be set-up by 10:00 a.m. and stay open until 4 p.m. when the Barbecue stops serving. If you leave early, you will not be allowed to return in future years. **Please do not bring your pets onto the school grounds.**

This is a community event on school grounds. All products must reflect good taste and be in keeping with the surroundings.
