## VENDOR APPLICATION PACKET

Thank you for your interest in the 74th Annual Laveen BBQ. We anticipate 7,000 attendees this year. Please read through the entire packet carefully. All vendors must show proof of an AZ Sales License on the day of the event.

A one-day permit can be purchased at [https://www.azdor.gov/TransactionPrivilegeTax\(TPT\).aspx](https://www.azdor.gov/TransactionPrivilegeTax(TPT).aspx). In addition, all food vendors must abide by the rules & regulations of the AZ Dept. of Health. Please review the guidelines for home baked goods, if applicable <http://www.azdhs.gov/>. We are not liable for any violations that any agency may enforce. It's up to the individual vendor to ensure that they are in compliance.

### VENDOR CATEGORY INFORMATION

1. There are five recognized vendor categories. Please select the category on the Vendor Registration Form that most closely matches your representation. Please contact us with questions at [BBQspace@Laveen.org](mailto:BBQspace@Laveen.org).
2. Separate businesses may not share a booth.

### VENDOR REGISTRATION INFORMATION

1. **NO APPLICATIONS ACCEPTED AFTER February 12, 2026. NO EXCEPTIONS.**
2. No refunds after February 14, 2026.
3. No verbal reservations will be taken. A check or money order for full payment must be included with the Vendor/Exhibitor Application or when registering online with Eventbrite.
4. Please note special requests on your application (direction to face, near fun zone, etc.) accommodations based on availability.
5. Only one product-reseller vendor permitted per company (i.e. one Avon, one Pampered Chef, one Origami Owl, etc.). Laveen residents will be given priority and application postmark or Eventbrite registration date will be the deciding factor in the case of duplicate entries.

### VENDOR EVENT INFORMATION

1. The Laveen BBQ takes place rain or shine, so plan accordingly!
  2. The vendor is responsible for any necessary fixtures. Wi-Fi and electricity are NOT provided.
  3. Vendor spaces are on grass and may not be level. If you have a canopy, you must anchor or weigh it down in case of wind. No stakes are allowed due to sprinkler lines.
  4. Vendor spaces are 11'x11' and must be staffed at all times. No soliciting or selling (including political signature collection) outside assigned booth space.
  5. Products displayed, sold or given away in the vendor area must not compete with the BBQ meals itself including ANY drinks of any kind. This includes water. You may sell or give away any product listed on your application so please be specific when listing your item(s). If you are selling homemade food, it MUST be approved and we reserve the right to deny any product.
  6. **No vehicles allowed in the vendor area after 9:30 am SHARP.** Fixtures, equipment, and supplies must be dropped off at the vendor site and vehicles immediately moved to the parking lot. No vehicles can be parked on grass or dirt areas. We do not provide dollies or hand carts. **All cars must be out by 10 am.** If you are driving an oversized vehicle or have a trailer, please let us know in advance.
  7. Vendors must be set up by 10:30 am and must stay open until 5 pm, no exceptions! No vehicles allowed in the area until 5:30.
- SORRY, VENDORS CANNOT BRING PETS TO THE EVENT!**
8. Vendors who fail to follow any of the guidelines outlined in this document will be asked not to return the following year. Vendors are responsible to ensure all employees and or volunteers adhere to the guidelines.
